"SHALL ORDINANCE NUMBERED 191ONS ADOPTED ON THE 21ST DAY OF DECEMBER, 1998, BE APPROVED, AMENDING ORDI-NANCE NUMBERED 1080ONS TO EXPAND THE PURPOSES FOR WHICH THE PROCEEDS OF THE ONE PERCENT (1%) SALES TAX LEVIED THEREBY MAY BE USED TO INCLUDE: (A) 7/8THS OF THE ONE PERCENT (1%) TO BE DEDICATED TO (i) CAPITAL IMPROVEMENTS, (ii) ECONOMIC DEVELOPMENT, OR (iii) THE PAYMENT OF DEBT SERVICE ON BONDS ISSUED BY THE CITY OR A PUBLIC TRUST OF WHICH THE CITY IS THE BENEFICIARY; (B) 1/16TH OF THE ONE PERCENT (1%) TO BE DEDICATED FOR SALARIES, EQUIPPING, TRAINING AND HIRING OF SHAWNEE POLICE OFFICERS IN EXCESS OF THE 1998-1999 FUNDING LEVELS; (C) 1/16TH OF THE ONE PERCENT (1%) DEDI-CATED FOR THE SALARIES, EQUIPPING, TRAINING AND HIRING OF SHAWNEE FIREFIGHTERS IN EXCESS OF THE 1998-1999 FUNDING LEVELS; TO ESTABLISH POLICE AND FIRE SPECIAL TAX FUNDS FOR THE MONIES COLLECTED UNDER SECTIONS (B) AND (C); AND ESTABLISH SAID ONE PERCENT (1%) SALES TAX TO BECOME PERMANENT ON JULY 1, 1999?"
