Leadership has the duty to protect the integrity of the game but it is everyone's responsibility to provide a safe environment and opportunities for kids.

Study: Integrity of the Game vs Economic Impact, The Oklahoma Business Plan... Self initiated doctoral study in an effort to find a solution to an unknown problem affecting a culture that seems to be out of control. My doctoral study is not singularly focused on USSSA but also houses a 5 year study on Tri-County Basketball & 5 years study for Lincoln County OK Kids Baseball.

The <u>United States Sports Specialty Association</u> (**USSSA**) is thriving in Oklahoma. This is due to facilitating a business culture that is unregulated without oversight creating a monopoly locking out national competition within the State of Oklahoma. The structure of **USSSA** is nothing more than a basic network marking formula. Each level within the association furthers themselves from legal responsibilities while reclaiming their share of the profits. USSSA National Office is located in the State of Florida.

Research: The State of Florida's AG has a current RICO filing vs USSSA and Oklahoma Consumer (parent money) does filter it's way all the way to Florida. Staying within the network marketing formula, each state has a USSSA Director that bought / purchased / advertised the individual ownership of all states, Oklahoma has a state director (resides in *Kansas*) and is a relative of an individual who has been specifically named within the State of Florida's Attorney General's Office RICO case. These state directors solicit USSSA Area Directors (boots on the ground) within their state who operate or lease sports facilities to host baseball / softball leagues and tournaments or part of a nonprofit/not-for-profit umbrella. The area director's within the state of

Oklahoma received \$11,547,043.00 through USSSA.com 2016-2023. The data is public and with data analysis a youth sports culture can be exposed. This has contributed to illegal business practices of not reporting wages and with embezzlement or questions where did consumer money go. A cash operation has flourished and I believe we no longer run youth sports leagues but rather run a youth sports umpire league that has no reported income.

Oklahoma Little League Baseball and Softball: As Vice President and was requested to Moore, OK. As I evaluate their situation and their desires to replace their current youth baseball provider, Moore Youth Baseball Association, I begin to include Moore, OK into my study and question \$750K of documented consumer funds. As I bring my concerns to light with the City of Moore it reinforces change but change never happens. The City of Moore facilitates the existing parties to operate the facility without accountability. Through my ability to obtain financials via the open records act and the history behind a municipality's failures to protect the public, those entrusted to manage taxpayer assets have failed their communities. Moore, OK is not just an isolated incident but this is happening and documented within my study across the State of Oklahoma.

<u>Complex Systemic Culture</u> failing families that has taken me 20 years to finally conclude my doctoral study recognizing how business practices impact opportunity for kids. National research indicates that the culprit behind the lack of recreational sports is Travel Ball. In my professional opinion here in Oklahoma Travel Ball has a shared responsibility in the decline however most municipalities are ignorant in what's taking place within their community or some are complicit and benefit.

<u>Legislature</u> oversight is never wanted but in drastic times measures must be taken. It is my responsibility to bring this to the attention of those who's boundaries or limits reach



USSSA provides a public platform that displays factual data giving insight creating a baseline that facilitates a theory that can now become... Problem-Solution.

Moore, OK. A covert operation took place via text messaging via umpires / embezzling youth group. It was a coordinated effort to put pressure on the local city manager who gave way to politics vs Integrity and the best interest of his community. He looked the other way and justified keeping the documented embezzlement user group in control of Buck Thomas Park for the 2024 calendar year. Moore, OK has shed tremendous insight and value for the future of Oklahoma Kids!

It was also <u>noted</u> by Michael (Plaintiff Attorney) that USSSA should be held accountable & give back to families. GamePlan: The business evolution of youth sports advances as technology becomes readily available with the ability to encapsulate a market. Consumers (taxpayers) provide a resource (public facilities) relinquishing authority of jurisdiction within their municipality government to manage in good constitute faith. As the business culture advances within Oklahoma, those entrusted to protect the integrity of the game essentially overtime become disenfranchised, trust or pushing responsibilities? This creates a ripple effect that facilitates questionable legal business practices in most of Oklahoma municipalities.

As outlined previously, the City of Moore, Oklahoma's entrusted leadership lacks integrity and has <u>failed their community</u>. Instead of exposing the discovery of financial and business concerns and holding those responsible accountable the City of Moore decided to look the other way. <u>Municipalities lack integrity</u> and some elected officials raise concerns of **complicity** vs **ignorance** are **incapable** of balancing their public vs business interests decisions.

I would propose creating a *pilot program* with a budget that gives me that ability to build *Baseball Heaven* as a cover but to continue to document and reinforce USSSA **RICO** and the non-USSSA activity in Oklahoma that is significantly larger than the United States Sports Specialty Association (USSSA) data documented within my data research. My study consists of data reflecting USSSA data as this is publicly displayed and cannot be disputed giving credence and validity to my doctoral study, Integrity of the Game vs Economic Impact (Politics), The Oklahoma Business Model...

Also keep in mind that while I have an <u>assumption</u> as to why... I have nothing to implicate other than a theory & the actions of others while in Seminole. **COVID** appropriations and those at committee levels. We discussed this some as my public graphics ability & generosity came under SSCEF scrutiny. We have city councilman complicit within my outlined usssa business issues but they reside outside of usssa activity further intractable and under the radar. As I search for corruption... I also have significant elevated concerns for Oklahoma Little


League and its Tulsa, OK Charter. Upon taking the VP Role in Oklahoma I've been researching
