

# My Own Prison: Reflections on The Journey – March 9, 2025

*Integrity of the Game vs Economic Impact (Politics); The Oklahoma Business Plan*

## Overview

This updated reflective entry, recorded during a 2024 walking session, deepens the exploration of personal loss and systemic challenges in Oklahoma's sports culture. I detail a business proposal for an indoor event center for batting cages, recount a near-miss traffic incident involving my son Brian, and reflect on how that moment—and a subsequent witness letter—reinforced his legacy as a guardian angel. The narrative traces the genesis of our memorial tournaments, initiated by high school baseball moms' desire to honor my son (despite an early rejection), and describes how these events evolved into a fundraising effort for a sports complex. The entry also examines the challenges of municipal oversight and contractual disputes, including issues with RFP processes, nonrefundable deposits, and concession negotiations, all of which are integrated into my ongoing doctoral research.
