In short, we've drawn on our comprehensive Oklahoma USSSA dataset (2001–2025), the Shawnee Minutes Dataset, case studies like Firelake Ballfields and Bouse Sports Complex, and decades of field experience to ensure each topic is grounded in concrete data and real-world examples.

Our Methodology:

- **Data Foundation:** We mined our Oklahoma USSSA dataset (2001–2025) for fee structures, team counts, and host revenues across counties.
- **Case Studies & Documents:** We integrated city meeting minutes (Shawnee, Choctaw), facility lease agreements, and contractor records to illustrate governance and financial flows.
- **Visualizations & Interviews:** Wherever possible, we'll incorporate charts (fee trends, budget allocations) and clips from district directors to bring the numbers—and the people—into the conversation.

Step-by-step walk-through of our proprietary visuals: bar graphs of budget allocations, line charts of fee inflation over two decades, and county-level profitability heat maps. Case studies—like team count dips at Choctaw's Bouse Sports Complex—underscore why data-driven governance is vital for equity and sustainability.

Episode Three: Two Types of Little League Play

Contrast "basic youth development" leagues (skill-focused, community-oriented) with the "Williamsport track" (competitive, all-star pipeline). We'll unpack age-cutoff rules, resource allocation, and volunteer training differences, helping parents and coaches choose—or blend—the models that best serve their athletes.
